## KEEP FOR YOUR RECORDS

1. **Product Rules:** Individual dealers/vendors may not prepare food or beverages on site. Food trailers and a concession stand will be open to the public. The sale of "Farm Fresh" products, such as eggs, requires a permit through the Greenbrier County Health Department. Knives, antique guns, muzzleloaders, bb guns, and airsoft guns are permitted. ANY OTHER WEAPONS OR COUNTERFEIT ITEMS ARE NOT PERMITTED.
2. **INDOOR vendors:** In order to have an Indoor space you **are required to stay all 3 days**. If you choose to leave early you will not be allowed to reserve an indoor space again.
3. **SPACE ASSIGNMENT:** Requests for a particular space may be included with this form and received in the office with payment by **September 1st, 2017**. After **September 1st**, spaces will be assigned by the SFWW Staff.
4. **SET UP TIME:**
  - o **OUTDOOR VENDORS:** Returning outdoor vendors from Spring 2017, may set-up between 1PM and 5PM on Wednesday, September 20th. All other outdoor vendors may set up on Thursday, September 21st, from 9AM-5PM.
  - o **INDOOR VENDORS:** Those with trailers may setup on Wednesday September 20th between 9am and 1pm. All other indoor vendors may set-up between 1PM and 5PM on Wednesday, September 20th or Thursday September 21st between 9am – 5 pm.
5. **TEARDOWN TIME:** All vendors are asked to stay open until 3PM on Sunday, September 24th and are encouraged to be off the grounds by 7PM on September 24th.
6. **FACILITY NOTE:** Vendors will have access to a shower/restroom facility. Camping is also available for a fee.

9. **VENDOR PARKING:** ANY VENDOR WANTING TO BE PARKED IN THE DESIGNATED PARKING AREAS DURING THE FLEA MARKET MUST DO SO BY 8AM. NO VEHICLES ALLOWED AFTER 8AM. IF YOUR VEHICLE IS PARKED ON YOUR SPACE, IT IS NOT ALLOWED TO MOVE DURING FLEA MARKET HOURS.
