## DRY / PRIMITIVE SITES

ONE TIME \$20 FEE PER UNIT

Registrations received prior to **July 22, 2017**, will be processed and the permit sticker returned via mail.

**THE PUBLIC CAMPING LOT OPENS AT 7 AM ON WEDNESDAY, AUGUST 9, 2017. ENTER THROUGH THE MAIN PARKING LOT ENTRANCE. DO NOT PLAN TO ARRIVE PRIOR TO THIS DATE OR TIME AS WE ARE NOT ABLE TO ACCOMMODATE EARLY CAMPERS. IF YOU ARRIVE PRIOR TO 7 AM ON 8/9 (Wednesday) YOU WILL NEED TO PARK SOMEWHERE OTHER THAN THE STATE FAIRGROUNDS.**

1. We will make every effort to provide night time shuttle service unless traffic congestion makes it unsafe.

3. Permit entitles you to one camping spot and up to two vehicles.

For the safety of everyone involved, camping is allowed in designated areas only, and at the direction of the State Fair parking personnel.

1. **Campground opens at 7:00am on Wednesday, August 9th, 2017.**
2. **NO ATVS PERMITTED IN THE CAMPGROUND.** Golf cart usage limited to visitors needing transport to main gate bridge area only; must provide proof of liability insurance; State Fair not responsible for lost or stolen equipment
3. **Due to the high volume of traffic, bicycles are not permitted in the campground area.**
4. **No "open" fires are permitted in the camping area. Fire pits and grills are allowed.**
5. **Possession/use of drugs, alcohol, and/or firearms is not permitted on the property. Excessive noise is not allowed.**
6. **No soliciting permitted on the property.**
7. **Pets must be either on leashes or otherwise confined at all times. Pets are not permitted on the main fairgrounds. Pets are not permitted in the bath houses. Owners are responsible for cleaning up after their pets.**
8. **One camper/tent plus two vehicles are allowed per camper/RV space. All other vehicles to be parked in the free parking area.**
9. **Camper is responsible for leaving the area clean. Use available trash containers; however, do not move from locations where originally placed by fair staff.**
10. **No liquid wastes allowed on ground surface—this includes sewage and gray water.**
11. **Camper is responsible for the actions and any destruction caused by others who are traveling with or visiting while camper is on fairgrounds property.**
12. **Camper is to observe quiet time between 11 pm and 6 am —ALL GENERATORS ARE TO BE TURNED OFF during these hours.**
13. **Camper agrees to pay for any damage he/she causes to the premises . Camper agrees to hold harmless and indemnify the SFVW, its officers, directors, and employees from and against any and all claims, demands, causes of action, liability, losses, damages, penalties, and expenses, including court costs and attorney's fees, arising from or incurred because of The Campers' actual or alleged actions or omissions with respect to the premises. The Camper assumes all risk of liability arising from or in connection with his rental of the camping space and other activities at the premises and assumes and shall bear all risk of loss or damage to, or theft or destruction of, his equipment and personal property at the premises. Camper must have the camping permit visible at all times. No camping without a permit.**
