No specimen entered in competition may be removed from the show room until 12 Noon, Saturday, August 18, except by special permission of the show superintendent. All stock must be removed by 6 p.m., Saturday, August 18.

Rules:

1. The SFWV will not be responsible for loss by accident, fire or providential destruction. All possible care will be used in receiving, cooping, feeding, caring for and return of rabbits. **ONLY ONE KIND OF FEED WILL BE FED BY ATTENDANTS.** Stock will be attended by competent workers and special attention will be given at all times. If your animal requires special feeding, such a request must be made, in writing, with your entry form. **YOU MUST TAKE CARE OF FEEDING AND WATERING YOURSELF.** Extra passes will NOT be given for you to return for special feeding.
2. No person shall handle his or her exhibits or any exhibits without permission of show officials.
3. Unless four (4) or more of a breed are exhibited, there will be no cash premiums paid. Ribbons will be awarded through fifth place.
4. **All specimens must be permanently and legibly tattooed in the left ear and have a temporary mark with coop number in the right ear. Animals with illegible ear numbers will not be permitted in the show.**
5. The management reserves the right to reject any exhibitor or livestock. Any entry form that omits information will be rejected. Management reserves the right to limit the number of animals entered by any one exhibitor.
6. **All rabbits must be at least 12 weeks old.**
7. Absolutely no breeding will be allowed in the show room.
8. **POSITIVELY NO SUBSTITUTIONS WILL BE ALLOWED, EXCEPT IN THE SAME CLASS, BREED, VARIETY AND SEX AND ACCEPTED AT CHECK-IN ONLY.**

9. No one except the officials will be allowed inside the judging arena. The decision of the judge is final in all cases and the right is reserved to substitute another judge in case of an emergency.
 10. **No litters will be accepted.**
 11. All entry forms must be mailed to the State Fair of West Virginia, PO Drawer 986, Lewisburg, WV 24910. Coops will be assigned on a first-come, first-serve basis.
 12. **Only rabbits entered in competition will be allowed on the grounds.**

Sales:

1. ALL SALES OF STOCK WILL BE HANDLED BY THE SHOW SUPERINTENDENT WITH NO SALES PERMITTED BY INDIVIDUAL EXHIBITORS. VIOLATION OF THIS RULE WILL RESULT IN FORFEITURE OF PREMIUMS AND ENTRY.
2. The Show Superintendents have the authority to screen all animals for sale and disqualify any that are questionable.
3. An exhibitor wishing to sell an animal must complete a legible sales sheet (enclosed with entry confirmation) and return it to the superintendents within one (1) hour after completion of judging. All stock sold will receive a receipt.
4. All sales will be on a "cash only" basis.
5. Any exhibitor or their representative discussing sales of their rabbits to interested buys will be subject to all of their sale animals being removed from sales unless prior permission from the Show Superintendent has been granted. Repeated offenses will have exhibitor subject to entire entry removed from competition and premiums forfeited at the discretion of the superintendents.
6. Sales will begin at opening on Saturday (10:00 am). Management has the right to change if necessary.

Best rabbit of the show, chosen by the official judge, to receive a special ribbon and a financial award of \$30.
