## KEEP FOR YOUR RECORDS

1. **Product Rules:** Individual dealers/vendors may not prepare food or beverages on site. Food trailers and a concession stand will be open to the public. The sale of "Farm Fresh" products, such as eggs, requires a permit through the Greenbrier County Health Department. Knives, antique guns, muzzleloaders, bb guns, and airsoft guns are permitted. ANY OTHER WEAPONS OR COUNTERFEIT ITEMS ARE NOT PERMITTED.
2. **INDOOR vendors:** In order to have an Indoor space you **are required to stay all 3 days**. If you choose to leave early you will not be allowed to reserve an indoor space again.
3. **SPACE ASSIGNMENT:** Requests for a particular space may be included with this form and received in the office with payment by **August 30<sup>th</sup>, 2019**. After August 30<sup>th</sup>, spaces will be assigned by the SFWV Staff.
4. **SET UP TIME:**
  - **OUTDOOR VENDORS:** Returning outdoor vendors from Spring 2019, may set-up between 1PM and 5PM on Wednesday, Sept 18<sup>th</sup>. All other outdoor vendors may set up on Thursday, September 19<sup>th</sup> from 9AM-5PM.
  - **INDOOR VENDORS:** Those with trailers may setup on Wednesday Sept 18<sup>th</sup> between 9am and 1pm. All other indoor vendors may set-up between 1PM and 5PM on Wednesday, Sept 18<sup>th</sup> or Thursday Sept 19<sup>th</sup> between 9am – 5 pm.
5. **TEARDOWN TIME:** All vendors are asked to stay open until 3PM on Sunday, Sept 22<sup>nd</sup> and are encouraged to be off the grounds by 7PM on Sunday, Sept 22<sup>nd</sup>.
6. **FACILITY NOTE:** Vendors will have access to a shower/restroom facility. Camping is also available for a fee.
