**TICKETING POLICY:** All livestock exhibitors will be issued **five complimentary tickets**. If livestock are required to be on grounds more than FIVE (5) days, additional tickets will be issued.

**PARKING:** Due to limited parking space there will be a \$10.00 daily fee for Livestock exhibitor parking. Spots are first come first serve. All exhibitors will be issued a livestock exhibitor identification tag to be eligible to park on grounds. Identification tag must be visible to drop animals off only. The exhibitor must be present in the vehicle to purchase one (1) parking pass per vehicle. No overnight parking will be permitted.

#### IMPORTANT FACTS

1. Youth and/or adult performance, llama halter and fleece classes may be combined if there are not enough entries in a division.
2. Any exhibitor who requests either a late arrival time or an early dismissal time must make such a request in writing to: Entry Department, PO Drawer 986, Lewisburg, WV 24901. All such requests will be handled on an individual basis.
3. Water and electric -- wash racks for large livestock are conveniently located near the barn.
4. Show photographer & overnight security are provided by the SFWV.
5. For camping reservations, please fill out Livestock Camping Form. Forms can be found by visiting [www.statefairfowv.com](http://www.statefairfowv.com) or by calling 304-645-1090.
6. In case of sickness of any llamas that appear to be in an unhealthy condition, the SFWV reserves the right to have them isolated or removed from premises.

#### REGISTRATION RULES FOR SHOWING

1. "LL" ILR registered llamas can only be shown in Halter and Fleece Classes.
2. ILR Registered crossbred llamas can only be shown in crossbred classes.
3. Exhibitors DO NOT have to be members of the ILR-SD to participate in your show. By being members, they will accumulate points for the animals they are showing; however, non-members are encouraged to show and will not be charged a non-member fee.

#### Exhibitors Entry Check List:

- ILR registration copies on each llama entered.
- Complete signed 2019 State Fair of WV Llama & Fleece Show Entry form. Please include entry fees!
- Please note your planned arrival and departure time on entry form and number of stalls needed for llamas, tack and display.
- A recent photo of your llama for display with each shorn fleece entry.

#### HEALTH REQUIREMENTS

**LLAMAS FROM WITHIN WEST VIRGINIA OR OUT-OF-STATE MUST BE FREE OF DISEASE. LLAMAS ARE REQUIRED TO HAVE A VET "CERTIFICATE OF GOOD HEALTH" ISSUED WITHIN 30 DAYS OF THE SHOW. VETERINARIAN'S ID NUMBER MUST APPEAR ON THE CERTIFICATE.**

The fleece show will be governed by the 19<sup>th</sup> Edition ALSA Handbook and ILR-SD Guidelines. All llama shorn fleece entries must be on the show grounds by **11am on Friday, August 16<sup>th</sup>**. Fleece & awards will be on display Friday & Saturday during the Llama show.

**The Classes are as follows:** (083-088 = shorn or 090-095 = walking)  
**83 or 090** Double Coat Up through 24 months  
**84 or 091** Double Coat 25 months and older  
**85 or 092** Single Coat Up through 24 months  
**86 or 093** Single Coat 25 months and older  
**87 or 094** Suri Coat up through 24 months  
**88 or 095** Suri Coat 25 months and older

**Additional division of classes: At the Judge's discretion, classes may be further divided in the following prioritized order: age at shear, color, gender. When dividing a class, the number of entries in each new class must equal or exceed 4 fleeces. Fleeces may be moved to a more suitable fiber class at Judge's discretion.**

Entry fees are **\$10 per Shorn or Fleece-On**. You may pick up your fleece Saturday, August 17th, 2019 after the Llama Show. Ribbons will be awarded to 3rd place. Cash Premiums \$25, \$20, \$15, State Fair of West Virginia Banners for Grand & Reserve Champion in each division Shorn & Fleece On. A special award will be given to our "Best of Show" shorn fleece AND fleece on.
