# GENERAL RULES AND REGULATIONS

## THESE RULES SUPERSEDE ALL OTHER RULES IN THIS EXHIBITOR'S GUIDE

1. The State Fair of West Virginia (SFWV) reserves to its Board of Directors the final and absolute right to interpret these rules and regulations and arbitrarily settle and determine all matters in regard thereto and to add to or amend them as they may deem advisable.
2. Upon the discovery of an aberrant act or unseemly behavior (including the consumption of alcoholic spirits) on the part of any exhibitor in the barn and in the public view, the Board of Directors, if such act is proved to their satisfaction, reserves the right to withhold the payment of any prizes awarded, to prohibit any such party or parties from exhibiting for one or more years, to publish the names of any such person or persons as may be deemed expedient, and to award a prize or prizes so withheld as though such exhibitor or exhibitors had not exhibited.
3. Advertisements by means of posters, prints, handbills, etc. on buildings, trees, posts or on other places on the grounds **will NOT be permitted**, nor will anyone be permitted to distribute any advertising except from inside of booth and not in the aisles in front of same.
4. **Exhibits brought to the Fairgrounds without having previously been entered at the Fair Office on the Fairgrounds will not be accepted.**
5. Personal cooking equipment, i.e. refrigerators, hot plates and grills, etc. will **NOT** be permitted in the barn area. Please confine these items to the campgrounds/camping area.
6. **All exhibitors who do not keep tack and/or stall space free of debris will be penalized! This includes cleaning stall space before leaving!** Premiums will be withheld.
7. **Any entry form NOT completely and correctly filled out WILL BE RETURNED TO SENDER.**
8. **A fee for ALL grooming chutes, stands, show rails, and/or any additional equipment must be paid for through the entry department. See entry form for details.**
9. Dogs are not permitted. A service dog must be under the control of its handler. Service dogs must be on a leash, harness or tethered per ADA guidelines.
10. **ALL exhibitors must have reached there 7th birthday on or before the date of showing**

**Exhibitors need to note the following deadlines:**

***12 Noon, Wednesday, July 6 for paper entries***

***12 Midnight Wednesday, July 6 for online entries***

Entry forms will be accepted beginning May 9 through 12 Noon, July 6. Any entry forms received before May 9 or after 12 Noon, July 6, will not be processed.

**ALL ENTRY FORMS MUST ARRIVE IN THE STATE FAIR OFFICE BY 12 NOON ON JULY 6.**

Hand-delivered entry forms will be accepted at the Administration Building on the Fairgrounds from 8:30 a.m. until 4:00 p.m., weekdays and from 8:30 a.m. until 12 Noon on July 6. Online entries will be accepted at [www.statefairfwpv.com](http://www.statefairfwpv.com) until 12 Midnight on July 6.

**ALL JUNIOR SHOW ENTRIES MUST BE ENTERED ONLINE AND MUST HAVE THE CORRESPONDING PROJECT WITHIN FFA OR 4-H!!**

## ENTRY RULES

1. We support public health initiatives with regard to animal and human contact in public places. We **strongly encourage** exhibitors to support these initiatives and refrain from eating and/or keeping food in the livestock areas. Hand washing facilities are located in the Fair Street and Cattle Barn restrooms, and portable hand-washing stations located in the livestock areas. Additionally, you will find hand sanitizer located in high traffic areas.
2. For the convenience of exhibitors, an entry blank is placed on the website. Intending exhibitors should **type or print** the department, class and section in which they wish to enter their article or animal, using the exact number in the Exhibitor's Guide. **Only one (1) person may list his or her articles on an entry blank.** If additional entry blanks are needed, copies may be made or call the Competitive Exhibits Department at 304-645-1090. You may also visit the Fair's website at [www.statefairfwpv.com](http://www.statefairfwpv.com), for more copies.
3. The same article or animal **cannot** compete for the premium of two (2) or more classes, except when otherwise stated in the notes of the department.
4. **No entry will be accepted unless accompanied by entry fee, in cases where fees are applicable.** In case of cancellation, fees **will not be refunded.** The SFVW Ag. Committee reserves the right to reject or refuse any entry it deems advisable.
5. Livestock Exhibitors will adhere to the schedule printed.
6. **ALL ANIMALS EXHIBITED, MUST COMPLY WITH THE SANITARY REGULATIONS OF THE DEPARTMENT OF AGRICULTURE OF THE STATE OF WEST VIRGINIA, LISTED ON THE FOLLOWING PAGES.**
7. **ALL ENTRY FORMS INCORRECTLY FILLED OUT OR INCOMPLETE WILL BE RETURNED TO SENDER!!**
8. **GENERATORS ARE PROHIBITTED IN THE BARN AREAS.**
9. **All grooming chutes, grooming stands, and/or any additional equipment must be paid for through the entry department. Please look at entry form for fees.**

## **WEST VIRGINIA FAIRS, FESTIVALS AND PUREBRED CONSIGNMENT**

### **SALES HEALTH REQUIREMENTS—2022**

#### **THE FINAL DISPOSITION OF ALL ENTRIES SHALL BE MADE BY A WVDA ANIMAL HEALTH INSPECTOR OR IN THEIR ABSENCE, A LOCAL FAIR OFFICIAL.**

This is an official interpretation of regulations promulgated under the authority of Chapter 19, Article 9 of the State Code of West Virginia. This applies to fairs, festivals and shows.

1. All livestock imported into the State of West Virginia for fairs, festivals, and shows shall be accompanied by an Official Certificate of Veterinary Inspection approved by the livestock health official of the State of origin. A copy of the approved Certificate of Veterinary Inspection shall be forwarded to the Director of the Animal Health Division, West Virginia Department of Agriculture, Capitol Building, Charleston, West Virginia 25305, and should be in his possession (5) five days prior to the arrival of livestock.
2. Official Certificate of Veterinary Inspections (CVI) is good for 30 days. All out of state cattle must have official identification listed on the health certificate.

***Any animal showing signs of a potential infectious or contagious disease will not be allowed to participate in the event.***

Note: Cattle and goats from other states with disease outbreaks may be required to secure a special permit from the Director of Animal Health Division, West Virginia Department of Agriculture, Charleston, West Virginia 25305, phone number (304) 558-2214, before being admitted into West Virginia.

**If the animal is to be sold other than for slaughter, purebred consignment rules apply.**

ALL LIVESTOCK MUST MEET THE STATE OF DESTINATION HEALTH REQUIREMENTS AS TO MOVEMENT OF ANIMALS. SOME VARIATION IS FOUND IN HEALTH REQUIREMENTS AMONG THE SEVERAL STATES.

**Official ID is a requirement for interstate movement for cattle, swine, sheep, and goats.**

## **HEALTH REQUIREMENTS FOR CATTLE**

All out-of-state cattle must be accompanied by an Official CVI with Official Identification listed. Health certificates are good for 30 days. Nursing Animals - move with Dam. No CVI is required but must be listed on dam's CVI. All out of state cattle must have official identification listed on the health certificate.

### ***Tuberculosis in Cattle***

*Cattle to be exhibited at West Virginia fairs, festivals and shows must meet one of the following requirements:*

#### **From West Virginia**

No test is required, if herd is not under quarantine for tuberculosis.

#### **From Other States**

1. From Bovine Tuberculosis Free State - No test required. Interstate CVI is required. All out of state cattle must have official identification listed on health certificate
2. From other than Bovine Tuberculosis Free State:
  - A. If originating from an accredited TB Free herd - no test required, or
  - B. If herd origin has had a complete negative herd test within 12 months - no test required, or
  - C. All other bovine require a negative TB test within 60 days of show.
  - D. Nursing calves may be shown on dam's negative CVI. All out of state cattle must have official identification listed on health certificate.

### ***Brucellosis in Cattle***

*Cattle to be exhibited at West Virginia fairs, festivals and shows must meet one of the following requirements:*

#### **From West Virginia**

No test is required, if herd is not under quarantine for Brucellosis.

#### **From Other States**

1. From Brucellosis Free State -No test required. Interstate CVI is required.
2. From other than Brucellosis Free State:
  - A. Official Brucellosis vaccinates under 24 months (beef) and 20 months (dairy) of age from herd not under brucellosis restrictions - No test required, or
  - B. Originating from a Certified Brucellosis Free Herd - No test required, or
  - C. Complete herd test within one (1) year before show - No test required, or
  - D. A negative Brucellosis test within 30 days. Nursing calves may be show on the dam's negative CVI. All out of state cattle must have official identification listed on health certificate.

**Health requirements continued....**

***Leptospirosis - Cattle***

*Recommended: Vaccinations for L. canicola, L. icterhaemorrhagiae, L. hardjo, L. Pomona, and L. grippotyphosa, are to be seriously considered.*

**HEALTH REQUIREMENTS FOR GOATS**

All out-of-state goats must be accompanied by an Official CVI good for 30 days.

***USDA regulation states that you must have an official Scrapie ID and the ID # must be listed on the CVI.***

***TB AND BRUCELLOSIS REQUIREMENTS FOR GOATS***

(No test required)

**NOTE:** Goats from other states with disease outbreak may be required to secure a special permit from the Director of Animal Division, West Virginia Department of Agriculture, Charleston, West Virginia 25305, Phone: 304-558-2214, before being admitted into West Virginia.

**SCRAPIE REQUIREMENTS FOR GOATS**

The following animals will need ID (ear tags or tattoos):

- All sheep and goats for exhibition require scrapie tags or tattoos.
- All animals must be tagged prior to leaving the farm.

**HEALTH REQUIREMENTS FOR SWINE**

.....

All out-of-state swine must be accompanied by an official CVI good for 30 days. Any swine born in West Virginia, and have never left the state, will no longer require pseudorabies testing prior to being shown at any fair or festival in West Virginia.

***From Other States***

All swine must be accompanied by a Certificate of Veterinary Inspection for entry into West Virginia. Swine from a pseudorabies-free state need no testing.

A West Virginia Department of Agriculture inspector will be stationed at the unloading dock to inspect them as they come off the trucks.

## **HEALTH REQUIREMENTS FOR SHEEP**

All out-of-state sheep must be accompanied by an Official CVI good for 30 days.

USDA regulations states that you must have an official Scrapie ID and the ID# must be listed on the CVI.

In order to properly inspect market lambs, they must be skin clipped prior to their arrival at the fair. A West Virginia Department of Agriculture inspector will be stationed at the unloading dock to inspect them as they come off the trucks between the hours of 10 a.m. to 9 p.m.

Any animal showing signs of an infectious or contagious disease will not be able to stay within the fairgrounds. Any shipment containing an infected animal commingled with other animals will result in the entire shipment being rejected. Lambs showing evidence of club lamb fungus will be WVDA inspected and may be asked to leave the fairgrounds.

### ***The following animals will need ID (ear tags or tattoos):***

- All sheep for exhibition require scrapie tags or tattoos.
- All animals must be tagged prior to leaving the farm.

## **HEALTH REQUIREMENTS FOR HORSES**

All out of state horses must be accompanied by an official CVI good for 30 days.

<b>From West Virginia</b>	<b>From Other States</b>

2. Have a negative Coggins' Test (from a USDA official approved laboratory) within the last 12 months.	2. Accompanied by an approved CVI from the state of origin prior to show or fair, <b>and</b>

### **Recommended Equine Vaccination**

Vaccination programs should include at least:

- Flu
- Eastern & Western Encephalitis
- Rabies
- Tetanus
- West Nile Virus

**Note:** No animals from any head or herds under restrictions will be permitted to show or sell. Animal Health Officials of the West Virginia Department of Agriculture reserve the right to examine any animal consigned and exclude animals from the show or sale that exhibits sign of disease.



**MINIMUM STANDARDS FOR THE HEALTH AND WELL BEING OF ANIMALS AND  
POULTRY ENTERED IN SHOWS/SALES AND/OR ON EXHIBITION AT  
THE STATE FAIR OF WEST VIRGINIA:**

1. Exhibitors of animals/poultry must comply with all health requirements under the authority of the WV dept. of Ag – Animal Health Division.
2. Animals/poultry must be in proper physical condition including such criteria as: no signs of obvious malnutrition, distress or signs of abuse, inability to ambulate normally, etc.... The State Fair of West Virginia reserves the right to grade entries prior to a class and excuse any entry not making an acceptable grade for show purposes.
3. All animals/poultry from an infected party developing evidence of infectious or contagious disease during the course of the Fair must be immediately removed from all State Fair of West Virginia property, including parking areas.
4. All animals/poultry must be provided adequate food, water, and clean shelter.
5. All entries must be clean and adequately groomed for show – making an acceptable presentation based on the individual species/breed/class.
6. The show judge has the authority to sift prior to judging a class – to eliminate any entry that does not meet his/her acceptable breed standards.
7. The WV Department of Ag. Animal Health Division officials, State Fair Show Superintendents and show judges, State Fair of WV Agricultural Competitions Manager, State Fair of WV CEO and Members of the State Fair Board of Directors, and WVU Extension officials have the authority to eject an entry at any point during the course of the entry's time at the Fair – including animals/poultry yet to be unloaded onto the grounds – if it is deemed there is a violation of the State Fair of WV Health and well being standards.
8. Should ejection of an animal/ poultry occur during the Fair it will result in non-refundable entry fees and no premium allocation for the ejected entry. Disposition of the animal/poultry will be at the exhibitor's expense. An exhibitor could also receive a suspension from future showing at the State Fair of West Virginia.

## Judges and Judging

1. **The decision of the judge is final.**
  2. Each livestock exhibitor is required to wear his/her entry identification number while in the judging ring.
  3. Any attempt to influence or intimidate a judge, or any attempt whatsoever to decide and obtain a premium by misrepresentation, shall be reported at once to the Agricultural Competitions Manager, who shall order that such exhibitor be excluded from competition at this exhibition and any premium that may have been awarded him shall be forfeited. This rule includes unethically fitted livestock.
  4. No exhibitor shall act as judge in the department in which he or she exhibits.
  5. If any disrespect is shown to judges by an exhibitor, or members or their family or their agent, they shall forfeit all awards received and the Superintendent shall make a report of same to the Agricultural Competitions Manager.

## Stalls and Stall Assignments

6. **Tampering with and/or changing barn space assigned by the department Superintendents is strictly prohibited. Stall space WILL BE adjusted according to the number of animals you bring.**
  7. Exhibitors will be required to keep their stall and space in a clean condition by removing any filth or litter, and placing it in the designated space where the sanitation department of the SFWV may get it with ease. **Those who do not follow will be penalized.** Premiums will be withheld.
  8. **All grooming chutes and/or grooming stands must be registered with the fair on the official entry form.**

### ADMISSION POLICY

Livestock Exhibitors will be issued a five (5) day complimentary ticket per entrant. If livestock are required to be on grounds more than five (5) days, an additional ticket will be issued. If more tickets are needed, please see our advanced ticket options. Other tickets needed must be purchased from the box office or [www.statefairfowv.com](http://www.statefairfowv.com). Other tickets will not be available for purchase through the Entry Department.

## ***IAFE Code of Ethics***

The State Fair of West Virginia has also adopted the International Association of Fairs and Expositions (IAFE) National Code of Show Ring Ethics, and its accompanying “Exhibitor Entry Statement” which is included on the livestock entry form and which livestock exhibitors are required to sign.

### **IAFE (International Association of Fairs and Expositions)**

#### **Code of Show Ring Ethics**

Exhibitors of animals at livestock shows shall at all times deport themselves with honesty and good sportsmanship. Their conduct in this competitive environment shall always reflect the highest standards of honor and dignity to promote the advancement of agriculture education. This code applies to junior, as well as open class exhibitors who compete in the structured classes of competition. This code applies to all livestock offered in any event at a livestock show. In addition to the “IAFE Code of Show Ring Ethics,” fairs and livestock shows may have rules and regulations which they imposed on the local, county, state, and provincial and national levels. All youth leaders working with junior exhibitors are under an affirmative responsibility to do more than avoid improper conduct or questionable acts. Their moral values must be so certain and positive that those younger and more pliable will be influenced by their fine example. Owners, exhibitors, fitters, trainers and absolutely responsible persons who violate the code of ethics will forfeit premiums, awards and auction proceeds and shall be prohibited from future exhibition in accordance with the rules adopted by the respective fairs and livestock shows. Exhibitors who violate this code of ethics demean the integrity of all livestock exhibitors and should be prohibited from competition at all livestock shows in the United States and Canada.

#### ***The following is a list of guidelines for all exhibitors and all livestock in competitive events:***

1. All exhibitors must present, upon request of fair and livestock show officials, proof of ownership, length of ownership and age of all animals entered. Misrepresentation of ownership, age, or any facts relating thereto is prohibited.
2. Owners, exhibitors, fitters, trainers, or absolutely responsible persons shall provide animal health certificates from licensed veterinarians upon request by fair or livestock show officials.
3. Junior exhibitors are expected to care for and groom their animals while at fairs or livestock shows.
4. Animals shall be presented to show events where they will enter the food chain free of violate drugs residues. The act of entering an animal in a livestock show is the giving of consent by the owner, exhibitor, fitter, trainer and/or absolutely responsible person for show management to obtain any specimens of urine, saliva, blood, or other substances from the animal to be used in testing. Animals not entered in an event which culminates with the animal entering the food chain shall not be administered drugs other than in accordance with applicable federal, state and provincial statutes, regulations and rules.

Livestock shall not be exhibited if the drugs administered in accordance with federal, state and provincial statutes, regulations and rules affect the animal's performance or appearance at the event. If the laboratory report on the analysis of saliva, urine, blood, or other sample taken from livestock indicates the presence of forbidden drugs or medication, this shall be the prima facie evidence such substance has been administered to the animal internally or externally. It is presumed that the sample of urine, saliva, blood, or other substance tested by the laboratory to which it is sent is the one taken from the animal in question, its integrity is preserved and all procedures of said collection and preservation, transfer to the laboratory and analysis of the sample are correct and accurate and the report received from the laboratory pertains to the sample taken from the animal in question and correctly reflects the condition of the animal at the time the sample was taken with the burden on the owner, exhibitor, fitter, trainer, or absolutely responsible person to prove otherwise. At any time after an animal arrives on the fair or livestock show premises, all treatments involving the use of drugs and/or medications from the sole purpose of protecting the health of the animal shall be administered by a licensed veterinarian.

5. Any surgical procedure or injection of any foreign substance or drug or the external application of any substance (irritant, counterirritant, or similar substance) which could affect the animal's performance or alter its natural contour, conformation or appearance, except external applications of substances to the hoofs or horns of animals which affect appearance only and except for surgical procedures performed by a duly licensed veterinarian for the sole purpose of protecting the health of the animal, is prohibited.
6. The use of showing and/or handling practices or devices such as striking animals to cause swelling, using electric contrivance, or other similar practices are not acceptable and are prohibited.
7. Direct criticism or interference with the judge, fair or livestock show management, or other exhibitors, breed representatives or show officials before, during or after the competitive event is prohibited. In the furtherance of the official duty, all judges, fair and livestock show management or other show officials shall be treated with courtesy, cooperation and respect and no person shall direct abusive or threatening conduct toward them.
8. No owner, exhibitor, fitter, trainer or absolutely responsible person shall conspire with another person or persons to intentionally violate this code of ethics or knowingly contribute or cooperate with another person or persons either by affirmative action or inaction to violate this code of ethics. Violation of this rule shall subject such individual to disciplinary action.
9. The application of this code of ethic provides for absolute responsibility for an animal's condition by an owner, exhibitor, fitter, trainer or participant whether or not he or she was actually instrumental in or had actual knowledge if the treatment of the animal in contravention of this code of ethics.

- 10. The act of entering an animal is the giving of consent by the owner, exhibitor, fitter, trainer or absolutely responsible person to have disciplinary action taken by the fair or livestock show for violation of this Code of Show Ring Ethics and any other rules of competition of the fair or livestock show without recourse against the fair or livestock show. The act of entering an animal is the giving of consent that any proceedings or disciplinary action taken by the fair or livestock show may be published with the name of the violator or violators in any publication or the International Association of Fairs and Expositions, including Fairs and Expositions and any special notices to members.
- 11. The act of entering an animal in a fair or livestock show is the giving of verification by the owner, exhibitor, fitter, trainer or absolutely responsible person that he or she has read the IAFE Code of Show Ring Ethics and understands the consequences of and penalties provided for actions prohibited by the code. It is further a consent than any action which contravenes these rules and is also in violation of federal, state or provincial statutes, regulations or rules may be released to appropriate law enforcement authorities with jurisdiction over such infractions.

**PREMIUMS**

- 1. Premiums will not be awarded simply because the animal or article is the best of its kind exhibited. The judge must consider it worthy of a premium upon its intrinsic merit or may refuse to award a premium of any kind.
- 2. In any class where there is no competition, the judge must sign a statement that the animal or article is worthy of first place money; otherwise, a blue ribbon will be awarded but only second money will be paid.
- 3. PREMIUMS WILL BE PAID ACCORDING TO THE RECORDS TURNED IN TO THE AGRICULTURAL COMPETITIONS MANAGER’S OFFICE BY THE SUPERINTENDENTS AND NOT BY RIBBONS PRESENTED.
- 4. **CHECKS NOT CASHED WITHIN 90 DAYS OF RECEIVING WILL BE VOIDED AND WILL NOT BE REPRINTED.**

**Note:** *If you entered in 2021, but did not show, you will need to contact the Entry Department to make arrangements for your credentials.*

**PARKING**

All livestock parking will enter through Gate 5, Livestock Gate on 219 North. Due to limited parking space there will be a \$10.00 daily fee for Livestock exhibitor parking. Spots are first come first serve. All exhibitors will be issued a livestock exhibitor identification tag to be eligible to park on grounds. Identification tag must be visible to drop animals off only. The exhibitor must be present in the vehicle to purchase one (1) parking pass per vehicle. No overnight parking will be permitted.

**Participation Statement**

- The American Angus Association®, 3201 Frederick Avenue, St. Joseph, Mo., will participate in premiums offered for open class Angus breeding cattle classes according to the premium schedule based on the number of head shown. The premium assistance provided by the American Angus Association for participation in this show is in addition to the premiums offered by the show itself. The premium assistance should not be used to offset show expense and shall be included in the premium payments distributed by the show to the exhibitors.
- A minimum of 50 head must be shown in the open class division to receive American Angus Association premium participation for the following year. Premiums from the Association are paid only to registered Angus cattle and only if the registration number is a part of the show report provided to the Association. Therefore, all cattle should be registered at the time of entry to make certain they receive the Association's portion of premiums. The Association does not pay on championship or any group classes, (i.e. get-of-sire, junior get-of-sire or breeder six-head).
- Exhibitors must have the original registration certificate issued by the American Angus Association available for inspection at the show for each animal or another current proof of ownership issued by the American Angus Association pedigree look up. Any animal, upon check-in, which does not have a legible permanent identification mark (ear tattoo marks, freeze-branded marks or hot-branded marks) corresponding to the permanent identification mark on the registration certificate, is ineligible to show. Once disqualified due to an incorrect or illegible permanent identification mark, animals cannot be re-identified (tattooed/branded) and rechecked at the show.
- Any female shown with a calf at side: the calf must be the cow's most recent natural calf, and the calf must be registered by show day and have proof of registration at check in.
- Only one person at a time shall lead an animal into the show ring.

*Exhibitors who participate in shows that accept premium monies contributed by the American Angus Association are subject to the Association Rules as found in the Breeders Reference Guide of the Association. These rules are found in Part 2; Association Rules. The rules relating directly with the exhibition of Angus cattle are Part 2: Association Rules; Rule 800 Series; including Rule 800 - 810. - Altering the conformation and/or appearance of an animal for exhibition is prohibited. This includes the covering of white skin, false tail heads (or use of any false hair), with the exception of false tail switches. The use of graphite, powders, hemp or other similar substances used externally are also prohibited. Other prohibited products include those used internally such as steroids, illegal or unlicensed pharmaceuticals or artificial filling. Any animal found to be in violation will be barred from showing.
- At any show for which the American Angus Association appropriates funds toward the payment of premiums, no exhibitors, individuals assisting exhibitors or member owners at such show shall be allowed to use any coloring agents, on any animal exhibited. The Association may adopt and implement various tests designed to monitor this prohibition, including but not limited to a “white towel” or “white glove” test. No aerosol cans or other pressurized containers will be allowed in designated line up areas. All animals exhibited are subject to DNA marker or blood type test to verify accuracy of parentage as covered under the Association Rules and for other testing as required by the individual show.
- Authorized representatives of the Association have the authority to enforce the rules set forth herein as well as in the Association Rules, including the barring of a registered animal from a livestock show at which it is to be shown, if there are reasonable grounds to believe a violation has occurred.

- All animals are subject to a medical examination in order to determine age, and each animal will be present in the show ring in its natural conformation without alteration or modification. Use of artificial tail heads are not permitted.
- Any animal not having a legible tattoo or firebrand number is ineligible and will be barred from showing.
- Bulls from classes 36, 37, 40, 41, and 42 must have a valid, satisfactory semen test certificate in possession. This certificate is valid for the entire show season.
- All animals shown in individual classes must be weaned, with the exception of the Cow/Calf Class and calves at the side of females that calved after Sept. 1, 2020. Calves at side must be purebred and registered with the AICA. Females calved after Sept. 1, 2020, must show in individual female class appropriate to age. Nurse cows are not permitted.
- All females 20 months and older exhibited at AICA sanctioned shows must be accompanied by a certificate of pregnancy from a licensed veterinarian or have produced fertile eggs as certified in a written statement by a licensed veterinarian or embryologist or have a calf at side.
- AICA requires that all animals be shown with a halter and suggest that all bulls be shown with a nose lead.
- ALL EXHIBITS OF CHAROLAIS BREEDING CATTLE SHALL BE GOVERNED BY THE AICA RULES AND REGULATIONS, ARTICLE XV, TITLED EXHIBITION OF ANIMALS. THE INSPECTION OF EXHIBIT CATTLE IS SPECIFIED IN ARTICLE XV, PARAGRAPH C, OF THE ASSOCIATION RULES AND REGULATIONS AND NON-COMPLIANCE OF EXHIBIT INSPECTION IS SPECIFIED IN PARAGRAPH D F THE SAME ARTICLE XV.
- ARTICLE XV, PARAGRAPH B, POINT 2: "Each animal will be presented in its natural conformation and structure without alteration or modification. Alteration or modification shall be defined to include any surgical, chemical, electrical or other (including branding or other circulatory constriction) appearance change for some cosmetic purpose, save only branding, tattooing, foot trimming or dehorning. The act of artificially filling animals internally, which would include some stomach pumping, drench tubes or any other method (by esophagus) is prohibited. Anabolic

steroid use shall likewise be prohibited and any animal testing positive for anabolic steroid or diuretic use shall be presumed to be altered and modified.”

**LEVEL 2 MEDAL OF EXCELLENCE (MOE) SHOW**

**North American Limousin Foundation Standard Rules and Regulations for the  
Exhibition of Limousin Cattle  
2022**

1. All animals must be registered with the North American Limousin Foundation (NALF).
2. Animals must be 75% Limousin (NALF percentage, not actual) or greater as indicated on orange NALF registration certificates or purple-papered Lim-Flex® cattle as indicated by NALF registration certificates. Percentage, full blood, purebred and Lim-Flex® cattle shall compete in the same classes and championships.
3. Animals must be properly tattooed and will be inspected at the show. Tattoos must be legible and match the registration certificates. If an animal's tattoo is not legible and cannot be read upon check-in, it will be ineligible to show and not be allowed to return to check-in with a new or corrected tattoo.
4. To maintain a high degree of confidence in Limousin shows, NALF reserves the right to disqualify any animal that has been fitted in an unethical manner. Unethical fitting shall include the following:
  - A) Any use of paints, hair coloring conditioners, colored show foam, graphite, colored powders or other substances; animals may be subject to a white towel test;
  - B) The addition of any hair or hair like substances, including false tail heads and false polls (false tail switches are allowed);
  - C) The cutting, tearing or gluing of the hide or underneath the hide or removal of tissue in an attempt to alter the shape of the animal or the injection of any gas, solid or liquid under the hide to alter the normal conformation.
  - D) Any products, solutions or liquids administered internally or externally to alter the conformation of the animal is prohibited. That includes the use of steroids, growth simulants, and the act of artificially filling animals internally, which would include some stomach pumping, drench tubes or any other method.

**EXCEPTIONS:**

In the case of severely sick or dehydrated animals, the exhibitor may have fluids or electrolytes administered by the licensed official show veterinarian with the approval of the show superintendent and/or North American Limousin Foundation representative. This exception is not applicable on show day or weigh-in/check-in day.

5. Bulls older than one (1) year must show with a nose lead. The Limousin show superintendent and the show management reserve the right to disqualify animals deemed unmanageable.
  6. Protests against exhibitors, individual animals or fitting violations must be submitted in writing and signed by five (5) active members if the North American Limousin Foundation and presented to the show superintendent within 12 hours of the show's completion.
  7. The North American Limousin Foundation reserves the right to inspect animals for dental ("mouth") development.
  8. NALF reserves the right to collect hair samples from any animal.
  9. Class size shall be to the discretion of show management and may not contain more than 20 head. The given classes may be split or combined only within their given division.
  10. Calves exhibited alongside dams in the cow/calf division **are eligible** to show as individuals.
  11. All animals shown must be solid red or black above the flanks, excluding birth marks.
  12. All cattle will be checked in before the show.
  13. If a show does not abide by the NALF MOE show rules, exhibitors won't be awarded points for that show.
  14. The West Virginia Limousin Association will pay 10% of the premiums offered.

**NOTE:** Failure to have performance data on file at NALF by the deadline will result in disqualification from the MOE program, and no points will be awarded. It is the responsibility of the breeder/owner/exhibitor to submit that information without special request from NALF.

### **Credibility Requirements**

To maintaining a high degree of integrity and credibility in all Limousin shows, all owners and exhibitors are expected to adhere to all NALF rules and regulations regarding the exhibition of Limousin Cattle and to adhere to rules and regulations of particular shows, fairs and exhibitions.

3. Cattle with horns longer than 1/4" will not be permitted to show.
4. Certificate of ownership and identification according to the breed organization will be required before showing of animals. All tattoos, identification of animals, and registration papers will be checked prior to showing.
5. Animals may be shown with a transfer. The department superintendent will collect the registration and transfer with the transfer fee (paid by check). The superintendent will then send the paperwork to the proper breed <sup>42</sup>

association.

6. **HERD UNIT** - If a herd is registered in the names of the immediate members of a family, these persons may combine their entries as a Herd Unit and be considered as one exhibitor. In order to qualify as a Herd Unit, all animals must be kept in the same herd. An animal owned by any person in the "Herd Unit" may be substituted for one owned by any other person in the Herd Unit. Animals bred by any members of the Herd Unit will be considered as having been bred by the Herd Unit.
7. **REFER TO ANIMAL HEALTH REGULATIONS.**
8. Cows 35 months old or over are eligible to be shown and must have produced at least one (1) calf.
9. **All animals must adhere to the above stated check-in times, including those animals coming from other fairs and festivals.**
10. Any cow under two (2) years old and in milk will be classed as two (2) years old or over.
11. **YOU MUST ENTER REGISTRATION INFORMATION FOR DAIRY CATTLE FOR ENTRY TO BE PROCESSED. SUBSTITUTIONS ARE ALLOWED.**
12. All exhibitors in individual classes must wear white pants. White shirts are preferred; however, colored dress "farm" shirts may be worn.
13. **NO EXHIBITOR SHALL BE PERMITTED TO WIN MORE THAN TWO (2) PREMIUM MONIES IN ANY ONE (1) CLASS.**
14. **To be shown at the State Fair of West Virginia, the dairy cattle breeds named below must have the following minimums of purebred ancestry, as are required by their national shows:**
  - A. **Ayrshire and Holstein must be at least 87% purebred.**
  - B. **Jersey must be at least a Generation Count (4) or higher.**
  - C. **Milking Shorthorn must be –EXP or full herd book.**
  - D. **Brown Swiss must be recorded as a Brown Swiss Step II Identify Enrollment (IE), a Certified Identity Enrolled (CIE) or a Standard Registered Brown Swiss Female.**

### **MILKING POLICY**

A modern milking parlor with trained operators is available. Exhibitors are urged and expected to cooperate in using the milking parlor which will be in operation during each day.

Personnel manning the equipment at the milking area are in charge. Personnel or staff recommendations or instructions shall be COMPLIED WITH by exhibitors, or anyone using milking parlor. Remember, spectators are observing the entire operation.

Proceeds from the sale of milk are placed in the State Fair Endowment which was created in 2006 and will provide long term support for youth scholarships. If exhibitors do not use this facility, their animals may be milked by their own portable units. Milk obtained in this manner must be removed from the grounds; in no instance may it be emptied into storm drains.

Milk handled at the State Fair of West Virginia milking parlor will be used for human consumption. Samples will be checked daily for the presence of antibiotics.

All exhibitors will be required to sign a statement confirming that all cows milked in the milking parlor have not been treated with any antibiotics or other medicines that will contaminate the milk. All cows may be subjected to antibiotic checks and exhibitors may be held responsible for contaminating bulk tank if samples from the exhibitors cows test positive for antibiotics or other contaminating medicines.

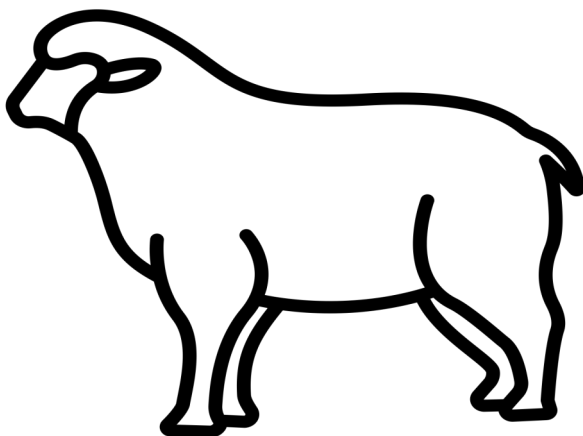

### **Competition Eligibility**

To be eligible to participate in the Department F - Junior Livestock Show, youth must be a current member of either a West Virginia 4-H Club or FFA chapter, and must be enrolled in either program by March 1 of the current year. The **ONLY** exception is Junior Dairy entries (See page 66.)

### **Entry Requirements**

1. **Junior show entries MUST BE MADE ONLINE by Wednesday, July 6 at 11:59 pm. NO PAPER ENTRIES WILL BE ACCEPTED!! A \$50 fee will be applied to late entries received by July 13th at noon.**
2. **All entries will be sent from the Fair Office to Extension Agents/FFA Advisors for approval. Exhibitors will be notified of approval by a letter before the Fair.**
3. Entry fees are **not required** for exhibits entered in the Junior Show. Junior exhibitors showing in open breeding classes must comply with registration requirements including entry fees for the open show. Open show entry fees must be paid at the time of entry. If showing purebred animals, please attach an email or mail a copy of registration papers.
4. **Exhibitors will pick up all gate tickets and exhibitor number upon arrival at the fair.**

### **General Exhibit Rules**

1. The General Rules and Regulations for the State Fair of WV apply to the Department F - Junior Show Rules and Regulations. All exhibitors must comply with both the General Rules and Regulations and Dept. F - Jr. Show Rules and Regulations.
2. All animals exhibited must comply with sanitary regulations of the Department of Agriculture of the State of West Virginia (refer to Health Regulations, pages 5-8).
3. The International Code of Show Ring Ethics listed in the General Rules and Regulations of the State Fair of West Virginia will govern all Junior Shows. (see pages 11-13).
4. Only animals entered in Department F - Jr. Show may be shown - no substitutes will be allowed.
5. Exhibitors must own, feed, care for, and house their animal at a designated and approved location when the animal is not kept at the primary residence of the exhibitor. Written approval must be obtained from the Country Extension Agent or Agriculture Education Teacher prior to ownership deadlines. The following ownership deadlines apply to all exhibitors:
  - Market Steers, Market Heifers - March 1, 2022**
  - Jr. Beef Heifers, Feeder Steers - June 10, 2022**
  - Dairy - June 10, 2022**
  - Market Hogs, Purebred Swine - June 10, 2022**
  - Market Lambs, Purebred Sheep and Market Goats - June 10, 2022**
6. Registration papers must indicate date of sale prior to ownership deadlines.
7. All Market Animals must be tagged with official RFID tag and a visual tag. If at the time of a specific species check-in a concern regarding identification arises, the situation will be handled by the species superintendent and the Department F - Jr. Show general superintendents.
8. Grand & Reserve Grand Champions: The 2022 Junior Show for market animals selected as Grand or Reserve Grand Champions will be a terminal show. This means that all Grand and Reserve Grand Champions must be harvested. There are two (2) options.
  - A. The youth may elect to consign their animal to the Greenbrier/Monroe Youth Livestock Association, Inc. Sale. After the animal is sold, the Greenbrier/Monroe Youth Livestock Association will assume responsibility for the animal and deliver it to a Designated

State of Federally inspected slaughter facility.

- B. The youth must consign their Grand or Reserve Grand Champion animal to the Greenbrier/Monroe Youth Livestock Association, Inc., Sale. After the animal is sold, exhibitor of the Grand or Reserve Grand Champion animal must maintain proper care and husbandry of the animal and its pen. If unable to do so, the exhibitor must provide in writing an explanation to the Greenbrier/Monroe Youth Livestock Association Board of Directors. It is mandatory that all Market animals selected as Grand or Reserve Grand will be sold in the Greenbrier/Monroe Youth Livestock Sale.

9. All Grand and Reserve Grand Champions will have a blood sample drawn immediately upon completion of the class. The sample will be sent to an independent lab for drug screening.
10. Exhibitors of Dairy, Purebred Sheep, Purebred Swine and Beef Heifers will be limited to **two (2)** animals per class in each breed. Exhibitors of all purebred animals must have registration papers in order and available at check-in for their respective sections. Photocopies are acceptable.
11. Exhibitors of Feeder Calves are limited to three (3) animals.
12. Exhibitors of Market Hogs will be limited to TWO (2) animals in the show. Market Hogs must comply with all health requirements set forth for breeding hogs. Market Hogs must weigh between 225 and 295 pounds. Hogs shown in market classes cannot be shown in purebred classes.
13. All Market Lambs will be classified by weight groups without regard to breed. All lambs must weigh 100 pounds to be eligible for the show. Each exhibitor is encouraged to tag a minimum of two (2) and can only tag a maximum of three (3) lambs. Each exhibitor may show up to three (3) single lambs. Lambs shown in market classes cannot be shown in purebred classes.
14. All Market Steers and Market Heifers must weigh a minimum of 1,000 pounds to be eligible for the show. Exhibitors of Market Steers and Market Heifers will be limited to three (3) animals in the show, one must be of opposite sex. Steers and Heifers, to be eligible to show, must have a complete set of baby teeth with no sign of permanent teeth, and the must have official identification.
15. All Market Goats must weigh between 60 and 110 pounds to be eligible for the show. Exhibitors of market goats will be limited to two (2) animals to show.
16. Please see separate Livestock Schedule on the Fair's website at [www.statefairfowv.com](http://www.statefairfowv.com) for Market Hog, Junior Beef, Market Lamb, and Market Goat check-ins.
17. Junior Purebred Sheep and Junior Purebred Swine must be delivered to the fairgrounds between 8 a.m. and 12 Noon on **Tuesday, August 16, 2022**. All animals must be accompanied by the exhibitor or an attendant.
18. Dairy animals that have been shown at the State Dairy Show have until 6 pm, on **Wednesday, Aug. 17**, to arrive. To see Dairy Lease Program for 2021, please contact your local Extension Office.
19. To ensure the opportunity for Junior Show Exhibitors to finish fitting their project animals on their own, an adult "hands off policy" on show days is strongly encouraged. Adults assisting are encouraged to involve the exhibitor in the animal preparation thus providing a "learn-by-doing" experience. Adults should serve as mentors and share equally the preparation.
20. No use of twine or other artificial materials on show animals are permitted. **See rule #5 of the International Code of Show Ethics.**

21. All exhibitors will place their animals in assigned stalls/pens and leave them there for the entire allotted time, unless authorized to move by any of the species superintendents of the Junior Show. Any exhibitor not delivering all animals entered will forfeit said space to be reassigned by the superintendent. Species superintendents and assistant superintendents are responsible for stall/pen assignments. Exhibitors must stay in the stall/pens assigned.
22. Purebred beef, sheep, swine and dairy, may be shown if the registration papers are prepared in the name of the 4-H and FFA member, 4-H club or FFA chapter or family farm name. Grade dairy animals are not eligible. See Dairy Lease Program.
23. **All junior beef heifers must check in with superintendent in the Large Livestock Arena . Please see separate Livestock Schedule on the Fair's website at [www.statefairfwv.com](http://www.statefairfwv.com).** All exhibitors of registered beef heifers must have registration papers for their animal ready to present with the animals at check-in. Photo copies are acceptable. Commercial heifers will also be checked-in at this time. **All animals must be properly tattooed.**
24. All fans and electrical equipment used in the barns must be in safe operating condition. No refrigerators, generators, or no butt fans will be permitted in the barns. No portable scales are permitted on the State Fairgrounds.
25. **Grooming chutes and/or grooming stands will not be allowed in aisles. ONLY ONE (1) CHUTE and/or STAND PER EXHIBITOR. (Exhibitors must bring his/her own chute/stand.)**
26. All animals entered in the show must be shown by the owner. If emergency circumstances prevent owner from exhibiting their animal, the superintendent must be notified in writing at the time of check-in. Superintendents may designate another junior exhibitor to show the animal. No attendants are allowed in the show ring, except the yearling breeding sheep classes. Attendants must be another junior exhibitor. The designee will be selected from other exhibitors in the same species.
27. An exhibitor number (provided by the fair) must be displayed in the ring when showing any junior livestock.
28. All exhibitors should wear hard leather shoes or boots. Exhibitors are strongly discouraged from wearing sneakers, tennis shoes, etc. No sandals are permitted in the show ring.
29. No advertising clothing is permitted in the show ring except for "4-H" or "FFA" apparel.
30. All class winners in the Junior Show must be shown for championship.
31. Persons causing disturbances or other problems in the Junior Show Barns will be asked to leave the grounds. (See rule #32 of the International Code of Show Ethics).
32. **Alcoholic beverages and illegal drugs are prohibited in the barns.**
33. Every exhibitor must be present or have a representative present. Roll will be taken. Any exhibitor not present or not represented will not be eligible for any premium monies.
34. Exhibitor's wishing to make stall requests must do so by email to [entries@statefairfwv.com](mailto:entries@statefairfwv.com).
35. **For ALL Purebred Animals, Please upload a copy of registration papers with entry.**
36. **NEW! No cable halters will be permitted in barn or show ring.**
37. **NEW! Loud music will not be tolerated.**



## **Showmanship Rules**

1. **All junior exhibitors are required to show in the showmanship contest for each animal species they are exhibiting. Those who do not show in showmanship will NOT be allowed to show in other classes or participate in Youth Livestock Sale.** In this rule, animal species refers to Market Hogs, Market Lambs, Market Steers, Market Goats, Market Heifers, Beef Heifers, Feeder Steers, Purebred Sheep, Purebred Swine and Dairy.
2. **All exhibitors MUST show their own animal.**
3. **It is required that all showmanship contestants wear clean dress shirts/blouses and dark trousers (jeans are acceptable). Exhibitors may wear 4-H or FFA shirts/jackets.** All white is acceptable for Dairy and Goat Showmanship. Participants may be penalized by the judge for wearing dirty clothing or inappropriate clothing.
4. The exhibitors in showmanship classes will be divided by age groups as follows:
  - a. Novice – 9 years old or in the third grade during the current 4-H year (October 2021 to September 30, 2022), and may not have reached their 12<sup>th</sup> birthday on or before January 1, 2022. All previous Novice winners must show in the Junior Division. *An individual who turns 9 at some time during the 4-H year may enroll if they are in the third grade. If the child is not 9 on October the first, they must be in the third grade on October the first, as the 4-H club year begins.*
  - b. Junior – 12 years old on or before January 1, 2022, and may not have reached their 14<sup>th</sup> birthday on or before January 1, 2022. Previous Junior Division winners must show in the Intermediate Division.
  - c. Intermediate – 14 years of age on or before January 1, 2022, and may not have reached their 17<sup>th</sup> birthday on or before January 1, 2022. Previous Intermediate Division winners must show in the Senior Division.
  - d. Senior – 17 years of age on or before January 1, 2022, and may not have reached their 21<sup>st</sup> birthday on or before January 1, 2022; FFA members may retain membership until Nov. 30, following the fourth National FFA Convention after graduating from high school. 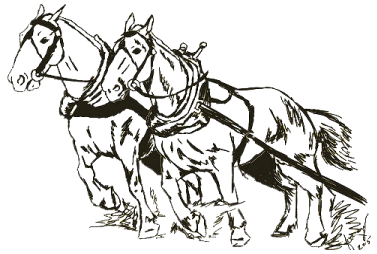
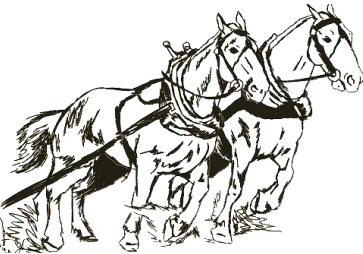

5. Market steers and heifers must be dehorned and healed.
6. **Ownership deadline is March 1, 2022.**
7. Grand & Reserve Grand Champions: The 2022 Junior Show for market animals selected as Grand or Reserve Grand Champions will be a terminal show. This means that all Grand and Reserve Grand Champions must be harvested. There are two (2) options.
  - A. The youth may elect to consign their animal to the Greenbrier/Monroe Youth Livestock Association, Inc., Sale. After the animal is sold, the Greenbrier/Monroe Youth Livestock Association will assume responsibility for the animal and deliver it to a Designated State of Federally inspected slaughter facility.
  - B. The youth must consign their Grand or Reserve Grand Champion animal to the Greenbrier/Monroe Youth Livestock Association, Inc., Sale. After the animal is sold, exhibitor of the Grand or Reserve Grand Champion animal must maintain proper care and husbandry of the animal and its pen. If unable to do so, the exhibitor must provide in writing an explanation to the Greenbrier/Monroe Youth Livestock Association Board of Directors. It is mandatory that all Market animals selected as Grand or Reserve Grand will be sold in the Greenbrier/Monroe Youth Livestock Sale.
8. All Grand and Reserve Grand Champions will have a blood sample drawn immediately upon completion of the class. The sample will be sent to an independent lab for drug screening. **All Grand Champion and Reserve Grand Champion market beef animals will be re-weighed upon completion of the class.**



9. If a concern regarding identification arises at the market steer check-in time, the situation will be handled by species superintendents and the Dept. F - Jr. Show General Superintendents.
  10. Only Exhibitors are allowed in the make-up area.

3. Grand & Reserve Grand Champions: The 2022 Junior Show for market animals selected as Grand or Reserve Grand Champions will be a terminal show. This means that all Grand and Reserve Grand Champions must be harvested. There are two (2) options.
  - A. The youth may elect to consign their animal to the Greenbrier/Monroe Youth Livestock Association, Inc., Sale. After the animal is sold, the Greenbrier/Monroe Youth Livestock Association will assume responsibility for the animal and deliver it to a Designated State of Federally inspected slaughter facility.
  - B. The youth must consign their Grand or Reserve Grand Champion animal to the Greenbrier/Monroe Youth Livestock Association, Inc., Sale. After the animal is sold, exhibitor of the Grand or Reserve Grand Champion animal must maintain proper care and husbandry of the animal and its pen. If unable to do so, the exhibitor must provide in writing and explanation to the Greenbrier/Monroe Youth Livestock

Association Board of Directors. It is mandatory that all Market animals selected as Grand or Reserve Grand will be sold in the Greenbrier/Monroe Youth Livestock Sale.

4. All market lambs will be classified by weight groups without regard to breed. **All lambs must weigh 100 pounds to be eligible for the show.** If there is any question concerning the actual weight, the lamb must be re-weighed immediately before it is taken back to the barn.
5. **All market lambs must be skin clipped prior to check-in with vet. officials.**
6. Each exhibitor is encouraged to tag a minimum of two (2) and can only tag a maximum of three (3) lambs. Each exhibitor must weigh-in at least **one (1) lamb** at the fair. Each exhibitor may show up to three (3) single lambs. Lambs shown in market classes cannot be shown in purebred classes.
7. *Lambs' tails are docked for cleanliness and to minimize fly strike, but cosmetic, excessively short tail docking can lead to an increased incidence of rectal prolapses and is unacceptable for the welfare of the lamb. We recommend that lambs' tails be docked at the level of the distal end of the caudal tail fold.*
8. Lambs shown in purebred classes may be not be shown in the market lamb show.
9. Lambs may be ewes or wethers.
10. Lambs must carry all lamb teeth and will be mouthed at the time of weigh-in. Wether lambs will also be examined at the time of weigh-in for the presence of testicular tissue. No animal with testicular tissue will be permitted to show. Species superintendents reserve the right to remove prolapsed lambs at any time during the exhibition.
11. In order to properly inspect market lambs, they must be skinned clipped prior to check-in with vet. officials . A West Virginia Department of Agriculture inspector will be stationed at the unloading dock to inspect them as they come off the trucks between the hours of 10 a.m. and 9 p.m. Any animal showing signs of an infectious or contagious disease will not be able to stay within the fairgrounds. Any shipment containing an infectious animal commingled with other animals will result in the entire shipment being rejected. Lambs showing evidence of club lamb fungus will be WVDA inspected and may be asked to leave the fairgrounds.
12. No muzzles are permitted.
13. All sheep pens must be bedded with an absorbent bedding.
14. If at the market lamb check-in time a concern regarding identification arises, the situation will be handled by the species superintendents and the Dept. F - Jr. Show General Superintendents.

Ear tags and tattoo will be checked upon entry into the ring and must be present for animal to show.
9. Species superintendents reserve the right to remove prolapsed animals at anytime during the exhibition.
10. All animals entered in the Purebred Sheep Classes must be registered in the recognized American herd books of their respective breeds.

NEW this year, to streamline our competition and give WV exhibitors an experience similar to what they might encounter at a national skillathon, exhibitors will complete the skillathon only once, and its content will be multi-species. The livestock skillathon will be conducted virtually. Participants in the skillathon will receive a username and password prior to the beginning of the State Fair. After logging in, participants will answer a series of questions that will test their knowledge regarding sheep, goats, beef, dairy and swine. The tested topics will be ones applicable to all the species exhibited. The first recorded score will be used for all species exhibited by a participant.

**Rules:**

1. Age Group Requirements:
  - a. **Junior** - 9 years old or in the third grade during the current 4-H year (Oct. 1, 2021 - Sept. 30, 2022) and may not have reached their 14th birthday on or before Jan. 1, 2022.
  - b. **Senior** - at least 14 years old on or before Jan. 1, 2022, and may not have reached their 21st birthday on or before Jan. 1, 2022.
2. **The 2021 Junior winners in the skillathon competition will participate in the Senior Contest. The 2021 Senior winners will sit out for one (1) year and will not be eligible for the competition in 2022.**

**\*Exhibitors must wear appropriate show number in order to show\***

#### **Rules:**

1. In the spirit of helping exhibitors, please observe the guidelines for adult assistance in each of the following divisions:
  - a. **Class 1 - 14 years old and under 21** - No adult assistance given. Fitting must be done by the exhibitor only.
  - b. **Class 2 - 10 years and under 14** - Adults may do minor assisting, but all fitting must be done by the exhibitor only.
  - c. **Class 3 - Six (6) years and under 10** - Adults may assist
  - d. **Class 4 - Under six (6) years** - Adults may assist
2. It is highly recommended that white clothes be worn.
3. One electrical outlet will be provided for each team.
4. Each contestant must provide their own clippers. Only one (1) set of clippers may be in use at any one time (i.e., one small set OR one large set; NOT one of each size).
5. No clipper blades smaller than a #10 will be allowed.
6. Fitting materials may consist of baby oil, dry clean solution, alcohol and/or five (5) gallons of water. If you have any questions concerning what you can use, please ask for clarification at the youth meeting prior to the contest.
7. Hooves are presumed to be trimmed. Knives and hoof polish are not permitted.
8. No more than one (1) of the doe's feet may be off the ground at any time.
9. The duration of the contest is 30 minutes.
10. At the end of the contest (when the 30 minutes is up), the animal must be presented to the judges. When time is called, you must stop everything!

The Official Milking Competition is sanctioned by the American Dairy Goat Association and its by-laws, Article IX, Division C, apply. Actual conduct of the milking competition, including positive identification of animals, weighing of milk and laboratory analysis for butterfat contest, will be preformed by the DHI Personnel. **Please have freshening dates available for DHI Supervisor at check-in. Please have available for DHI Supervisor to check tattoos and papers.**

Does may earn ADGA State Milker designation at this competition if they earn enough points to meet ADGA Division IX. C5 for each pound of milk, one point figured to two decimals; plus for each complete 10 days the doe has been in milk since last kidding, one-tenth (0.10) of a point with a maximum for 3.6 points; and for each 0.05 pounds of butterfat yielded in the day's milking, one point. Any doe earning 18 or more points will be awarded an Automatic \*M (Star Milker) designation without owner application or fee. Applications for a certificate are available through ADGA.

Since this is a DAIRY GOAT exhibit, each doe in milk brought onto the Fairgrounds MUST be entered in the Official Milking Competition.

### **RULES:**

1. This public competition shall receive prizes and premiums supplied by the State Fair of West Virginia.
2. Does will be milked in the same order for all three milkings. Does may be scratched from this competition.
3. The first milking test will be considered the preliminary milking for the State Fair Milk Out. The milk weight from the 2nd and 3rd milking shall be added to arrive at the total milk produced in 24 hours. In addition, the ADGA credit for time since last kidding (0.10 points for each complete 10 days since last kidding) shall be computed by the Superintendents. This total milk and "leg" shall be the final composite score and the basis for determining placements.

### Rules pertaining to the Boer Goat Show:

1. All goats must be registered in the ABGA Herdbook before the day of the show. Recognized associations include the American Boer Goat Association. Original registration certificates are required, though a copy of a Registration Application, stamped with the date received by the ABGA, can be accepted for kids less than three (3) months of age. Animals must be registered in the name of the exhibitor and must have been owned by the exhibitor on or before the date of the show. Throughout the ABGA and JABGA show rules the term exhibitor is defined as the owner of the animal listed in the ABGA registry shown on the entry deadline.

2. All goats must have legible tattoos or other means of permanent identification consistent with its registration certificate or the animal will be disqualified. Point winners from each class must have their tattoos read and recorded. The judge will be responsible for ensuring that the tattoos are read and properly recorded. The show secretary will be responsible for recording the tattoos and informing the judge as to which goats will need to be checked. If the animal has a microchip as its permanent identification, the exhibitor is responsible for providing a microchip reader.
3. Goats entered under the ABGA registration number and presenting the ABGA Certificates of Registration will be eligible to earn points for their actual placing in the show as described in the ABGA "Criteria for Ennoblement of a Boer Goat."
4. Birthdates, as listed on the registration certificate, will be used to determine the class divisions.
5. All animals must be registered purebred, Fullblood or Percentage Boer Goats. Percentage doe classes are for goats 50% to 80%, Purebred/Fullblood classes are for does that are 93.75% and higher, 96.87% and higher for bucks. Bucks 96.86% and lower are not eligible to be shown. Progeny of fresh does will not be allowed in the ring. At the discretion of the judge and superintendent, goats may be let loose in the ring as a function of judging. The Champion and Reserve Champion classes will be chosen from the first and second place animals in that division of the show.
6. Any goat showing any pronounced defect or abnormality will be barred from the show in any breeding classes. Artificial coloring will be a disqualification as well as illegible tattoos or tattoos that are inconsistent with the goat's registration papers.
7. **REFER TO HEALTH REGULATIONS.**
8. **No exhibitor will be paid premiums for more than the two (2) highest places earned in any single class.**

## **JUNIOR AMERICAN BOER GOAT SHOW**

### **Rules Pertaining to the Junior Boer Goat Show:**

1. Exhibitors must be in accordance of the JABGA By-Laws in terms of age and be an active member of the Junior American Boer Goat Association. Must present Current JABGA Membership card at check-in.
2. If the child is present and physically able, they must show their own animal unless they have multiple entries; then they must have another JABGA member to show the animal for them.
3. If the child is physically unable or not present due to specific circumstances involving death in the family, family emergencies, religious reasons, or any activity deemed and approved by the youth coordinator and youth committee; they must have a JABGA member show for them, and it must be reported before the goats arrive at the show.
4. JABGA members under the age of twelve (12), as of Jan. 1, or members with physical or mental disabilities are allowed to have a heeler in the class, but the member must help in the presentation of the animal. The heeler must present current membership card upon entering the ring with exception of the JABGA National Show, where current JABGA board members will serve as heelers when needed.
5. All goats that are not bred and owned over the age of ninety (90) days must be in the herd book thirty (30) days prior to being exhibited at a JABGA sanctioned show. All goats must be registered in the JABGA member's name only. No ranch or family name can be listed in the owner section of the certificate.
6. Effective January 1, 2016, JABGA member's may show goats registered in siblings/ stepsiblings names at any JABGA sanctioned show with an approval letter. An approved letter from ABGA must be presented to the show secretary.
7. JABGA will divide the membership into four (4) age divisions for the purpose of JABGA activities and Showmanship Classes:
  - A. PeeWee Division (4-6 years of age)
  - B. Junior Division (7-9 years of age)
  - C. Intermediate Division (10-14 years of age)
  - D. Senior Division (15-18 years of age)
8. Exhibitors entering showmanship must use a goat that is registered in his/her name and entered in the JABGA show. If a sibling letter is presented, exhibitor may use a siblings/ stepsiblings goat that is entered in the JABGA show. See rule #6 for sibling/ stepsibling exhibiting rule.
9. All show results received by the JABGA will be final.
10. All ABGA rules, breed standards, classes, judges and entries apply. All JABGA Sanctioned shows are required to have a BRED AND OWNED CLASS. One class each for the PERCENTAGE DOES, FULLBLOOD DOES and FULLBLOOD BUCKS. All ages will compete in one class. Awards will be given to the top placing goat per class. Use Class point chart, but double the points awarded for Bred and Owned classes only.
11. The show season will start on January 1, 2022 and will conclude on December 31, 2022.



- 12. The JABGA reserves the right to not sanction and/or to not tabulate placing's for points submitted by a show or not yet submitted by a show that didn't follow the ABGA rules, breed standards, classes, judges and entries.
- 13. The JABGA strongly suggest that JABGA members own and care for his/her own goats. Directors and members of the JABGA discourage unethical ownership and care.
- 14. Exhibitors and parents should always conduct themselves in a sportsman like manner. Infractions of this rule may cause immediate termination of the membership by a majority vote of the Board of Directors.
